CORE NEEDS, RECOMMENDATIONS, and ACTION STEPS

presented at October 2012 full Council Meeting

From Wood County FCFC By-Laws of 3/21/2007:

"The purpose of the Family and Children First Council is to provide a vehicle that brings together local leaders in political and administrative positions who value families and are committed to community services that raise the general health and well-being of children; and ... to participate in the development of a county wide, comprehensive, coordinated, multi-disciplinary, interagency system for infants and toddlers with developmental disabilities or delays and their families ... "

"the partnership shall support programs for which Family and Children First Council has been assigned oversight responsibility and based on the following core values:

- Heighten the level of community advocacy on behalf of local children
- Provide collective direction to the local public system serving children
- Increase funding opportunities available for multi-need youth
- Resolve system barriers and disputes when they arise
- The local system of care is community based, with the focus of services, as well as management of these services and decision making responsibilities, resting at this community level
- The local system of care is child centered, with the needs of the child and family dictating the types and mix of services provides ... "

Ohio Family and Children First Council

The purpose of Ohio Family and Children First is to help families seeking government services by streamlining and coordinating services, resources, and systems.

I. NEED – Make best use of available resources & position W.C. for resource acquisition RECOMMENDATION - Actively promote inter-agency/department collaboration – take to new levels – encourage shared/blended resource use for service delivery (in-kind & financial) wherever possible for both existing & potential resources – position Wood County for best resource use & acquiring emerging resources

Action Steps:

- 1) Review purpose of FC2 with full membership and revise By-Laws, if needed, to elevate emphasis on collaborative efforts in responding to identified needs with existing in-kind and financial resources.
- 2) Promote alertness of FC2 membership to potential resources that may be useful in advancing need-responsive initiatives.

II. NEED – Multiple data sources exist but are not easily accessed RECOMMENDATION - Promote use of shared data – FC2 Assessments, W.C. Youth Survey, Health Survey, & other data/information – accessible online/one web location Action Steps:

- 1) Make all child/family assessment data readily available on web site and/or through centralized database system (see V below.)
- 2) Promote integration of various surveys/assessments to avoid duplication of effort and multiple requests on districts of student time to complete surveys.
- III. NEED Lack of awareness of available resources persists among public RECOMMENDATION – Continue providing "No Wrong Door" trainings – for new staff (turnover) of all levels: support, administrative, service, executive Action Steps:
 - 1) Redevelop "No Wrong Door" committee and charge with developing continued training program for agency staff.
- IV. NEED Lack of clarity about existing groups & what issues they are working to address RECOMMENDATION **Develop broad list & description** of child/family groups/entities
 - a. extend invitations for participation in Family & Children First Council

b. coordinate resource map through "Balance Score Card" process

Action Steps:

- 1) Survey FC2 members of awareness of child/family focused groups and committees, along with focus, purpose, members & leadership.
- 2) Compile into organized listing of groups and include in resource database.
- 3) Invite leaders of identified groups to attend and participate in FC2 meetings and initiatives.
- 4) Add mini-presentation (10 minutes) of a featured program/service/group to agenda of each Council.
- 5) Explore "Balanced Score Card" approach to resource mapping.

V. NEED – Multiple resource listings, accessed differently

RECOMMENDATION – Work toward **integration of various resource listings** into one consolidated data set & access point – 211, Link, Pre-school Directory, Prevention Guide, Ohio's "Red Treehouse" project, & others

Action Steps:

- 1) Establish task group to develop a unified resource database accessible to agencies and public that is user friendly and maintained current as a primary/single source of service information.
 - Incorporate 211, The Link, ATOD Resource Guide, Early Childhood resource directory, No Wrong Door, Red Treehouse Project, and others into a consolidated resource listing/database.
 - Meet with United Way 211 personnel to explore integration of resource listings.
 - Utilize offered staff resource of W.C. Juvenile Court & others to advance this effort.
- VI. NEED Barriers exist to county-centered service delivery RECOMMENDATION – Consider expanding service outreach in local communities/ schools as alternative to county centered service delivery – perhaps utilizing "Schools as Community Hubs" model – (may relieve portion of family transportation with local service access)

Action Steps:

- 1) Develop task group to explore "Schools as Community Hubs" as service delivery model where needed in Wood County.
- 2) Survey perceived service needs to support student success of each school district through Superintendents, Principals, and other key school personnel.
- 3) Survey agencies and programs for interest and availability of potential service resources that might be delivered through a school-based model.
- 4) Match school needs and available resources wherever possible on a district by district basis.

VII. NEED – Assessment data reveals needs at all age levels

[go to <u>http://wcesc.org/resourcess</u>, select FC2 Documents tab at top] RECOMMENDATION – Advance each focal age-level area through Committees – utilizing existing groups where possible: <u>Early Childhood</u> (Early Childhood Collaborative), <u>School-Age</u> (Community Learning Centers/others), <u>Adolescent</u> (Prevention Coalition/ATOD), <u>Transitional Youth/Young Adult</u> (emergent/newly formed); <u>Adult/Parent Support/Elderly</u> (CRC, Parent Project, Guiding Good Choices/Senior Centers)

- a. Broaden membership of Family & Children First Council to include chairpersons of each Committee as full member
- b. Promote awareness & support of each Committee through inclusion on monthly FC2 agendas

Action Steps:

- Identify or develop a committee for each focal age level to advance need-responsive initiatives for their respective age levels (Summit issues.)
 - o <u>Early Childhood</u> (Early Childhood Collaborative / Children's Advisory Council)
 - <u>School-Age</u> (Community Learning Centers/others)
 - <u>Adolescent</u> (Prevention Coalition/ATOD)
 - o <u>*Transitional Youth/Young Adult</u>* (emergent/newly formed)</u>
 - <u>Adult/Parent Support/Elderly</u> (CRC, Parent Project, Guiding Good Choices, Senior Centers) *Health Dept. has expressed desire to have an active representative participate in each of these groups.
- Promote and support their efforts by including updates on their work on the Agenda of each Family & Children First Council meeting.
- Consider include the chairperson of each committee as a full member of Family & Children First Council.
- Have each FC2 member organization nominate potential parents/family members that would be valuable additions to FC2 membership.
